Milton has been a professional photographer for his entire working life. He has worked as a photojournalist for the Adelaide News, The Australian, London Daily Express, the Australian Womens Weekly and the Bulletin. He was the inaugural national president of the Australian Society of Advertising, Commercial and Magazine Photographers (ACMP) and has served on many other national committees.

Milton established Southlight Photo Agency in the early 1980s as a cooperative for freelance photographers. He closed the large studio and now operates Southlight and his photographic business from an office still in the heart of Adelaide. Milton is the author of 'A Year in the Life of Grange', which was awarded Worlds 'Best Wine Book Photography' at the Gourmand Wine and Cook Book Fair at Beijing, and a Silver Award in the American Publishers Awards in the Coffee Table Book Category. Milton writes a blog called 'People of Wine : Ten Question, which features interviews and stories about the many people in the wine industry he has met over the years.
